Chairman Ahlin opened the meeting at 6:05 pm.

Approval of Minutes

The minutes of the following meetings were presented; April 30, 2013 (Regular Meeting); May 15, 2013 (Regular Meeting); June 4, 2014 (Regular Meeting); July 16, 2014 Regular Meeting); July 23, 2014 (Regular and Executive Meeting); October 15, 2014 (Regular Meeting); December 4, 2014 (Regular Meeting).

Motion to accept minutes as presented was made by Carlisle. 2nd by Ahlin. Vote: Unanimous

Complaint by Richard Coughlin of 40 Watatic Pont Road about neighbor's street lighting

Mr. Richard Coughlin attended meeting to voice complaint regarding neighbor's street light is too bright and is causing "light trespass" onto his property. Site was inspected by both Rivers, Carlisle and Ahlin. Rivers noted that lights are approximately 130 feet from Coughlin's property and downhill. 100 watt bulbs were replaced last fall with 50 watt bulbs of similar lumen output. Rivers presented board with a letter from Florence Criscuolo the neighbor who states that the lights have been in their present locations since the 1950's with no complaints. She is upset that the lights keep getting vandalized by being shot out, painted over, and covered. She wants the police to prosecute the issue. Rivers contacted some of the other neighbors who have no issues with the lights. Mr. Coughlin admitted that he did enter on Criscuolo's property to tape overs over the lights, but denied otherwise vandalizing them. Coughlin bought his house in 2006 and now wants complete darkness in his area of the neighborhood except for his own lights, some of which operate on motion sensors. Rivers said that both Criscuolo and Coughlin have confirmed that Coughlin has never spoken to Criscuolo about the light issue. Coughlin is unwilling to pay to relocate the light poles if Criscuolo were to agree to have us move them.

Determination: street light is a private light rented from AMLP. AMLP has no jurisdiction regarding this matter as it is a civic issue. It was suggested by the Manager and Board members that Mr. Coughlin discuss this matter with neighbor to determine if a mutually agreeable solution could be agreed upon.

FY 2015 Budget Discussion and Financials

Manager Rivers presented a preliminary budget to the AMLP Board for FY2015. Preliminary budget is \$37,000 less than FY2014 budget. Decreases due to replication of items in past budget as well in savings in fuel costs. A previously voted 3% increase in wages, benefits and related expenses was noted.

Discussion regarding funding of new computers and a new bucket truck through a Bond or as a Capital Expense. An Energy Audit of the AMLP will be conducted in near future.
