Meeting Minutes

Carlisle called the meeting to order at 9:05 am with a roll call vote. Carlisle present, Hogan present (Ahlin arrived @ 9:21am).

Carlisle announced all Board meetings are subject to audio and video recording.

Hogan made a motion to accept the agenda as written. Carlisle seconded. All in favor. Hogan aye, Carlisle aye.

Hogan made a motion to approve the July 15, 2020 open session meeting minutes. Carlisle seconded. All in favor. Hogan aye, Carlisle aye.

General Manager Items:

Solar Installation(s) Update: Sullivan informed the Board that one customer went live in May and two additional customers are expected to go live with their installations by the end of the year. On 9/2 letters were mailed to the remaining twenty customers on the list and Sullivan has begun scheduling meetings with customers.

Squirt Bucket Procurement Update: Sullivan put in the cab/chassis bid with CommBuys and the bid specifications were sent to three Ford dealers and all the upfitters who are part of the CommBuys contract. The bid responses will be opened at noon on 9/24. Sullivan will work on the aerial lift late October to early November.

Apprentice Lineworker Update: Sullivan stated that the individual has been selected to fill the apprentice position. Sullivan is finalizing all the details before the offer letter is given. The anticipated start date is mid-October.

ISO-NE Reconstitution of Load: Sullivan discussed the details regarding the ISO-NE reconstitution of load. He said this could impact the strategic plans of the AMLP.

Tree Trimming Contract: Sullivan informed the Board that he has updated the Tree Trimming bid and it is ready for an October bid release. He is looking into possible

changes to be issued by the MA Department of Labor to the job classifications from Tree Trimmer and Tree Trimmer Groundman to Hoisting Engineer and Laborer.

The next meeting for the Board was scheduled for October 21, 2020 at 9:00 am.
